## Introduction

The information we receive, and how we use it, depends on what you do when visiting our Website. We may collect and use your non-personal information differently than your personal information.

## Personal information

Personal information is information we collect through this Website that we can use to specifically identify or contact you, such as your:

- name
- telephone number
- address
- e-mail address
- employer

In some places on this Website you have the opportunity to send us personal information about yourself. For example, you may fill out a registration form, a survey, or an e-mail form.

You also may choose to allow us to personalise your visits to the Website, in which case we will ask you for certain personal information to make your visits to our Website more helpful to you. ## The Sharing of personal information with third parties

Constructor Group will not share your personal information collected from this Website with an unrelated third party without your permission, except as otherwise provided in this Privacy Policy.

In the ordinary course of business, if you grant us permission, we will share some personal information with companies that we hire to perform services or functions on our behalf. For example, we may use different

vendors or suppliers to ship you products that you order on our Website. In these cases, we provide the vendor with information to process your order such as your name and mailing address. In all cases in which we share your personal information with a third party, we will not authorise them to keep, disclose or use your information with others except for the purpose of providing the services we asked them to provide.

We will not sell, exchange or publish your personal information, except in conjunction with a corporate sale, merger, dissolution, or acquisition. You have at all times the right to access to, rectification of and objection to the use of the personal data.

We may be legally compelled to release your personal information in response to a court order, search warrant, law or regulation. We may cooperate with law enforcement authorities in investigating and prosecuting Website visitors who violate our rules or engage in behaviour, which is harmful to other visitors (or illegal).

We may disclose your personal information to third parties if we feel that the disclosure is necessary to:
